Dear Friend,

A mental health crisis is looming in New Jersey, and it ultimately will affect ALL of us, not just the tens of thousands of people with mental illness who face losing access to treatment.

I know that sounds like an extreme assertion, but other states are already experiencing the dire fallout of an underfunded mental health system. In Michigan, for example, 10,000 people lost services when that state moved to fee-for-services funding of mental health, the process New Jersey is now undergoing.

Based on financial projections, most providers in New Jersey will have to eliminate services, and some agencies will shut their doors.

The new funding system not only underfunds key services like medication management, it makes no provisions to help people who have insurance but cannot afford their deductibles and copays. The bottom line is, only people who are on Medicaid or who can afford to pay out of pocket will get treated.

Even before the fee-for-service plan is implemented, the safety net that has existed for nearly four decades has shown signs of fraying due to a near-freeze in mental health funding over the past eight years.

New Jersey emergency departments treated 117,000 more patients in 2015 than in 2014, and 46 percent of that increase involved patients with a mental health or substance abuse diagnosis, according to the New Jersey Hospital Association's latest annual report.

People who cannot afford treatment at community providers will wind up in our state's emergency rooms, jails and state psychiatric hospitals. That carries a heavy ethical and financial price tag!

I ask you to take action! Please contact your legislators and demand they adequately fund the community mental health system. (Go to <a href="http://www.njleg.state.nj.us/SelectMun.asp.">http://www.njleg.state.nj.us/SelectMun.asp.</a>) New Jersey must increases key reimbursement rates, fund a sliding scale payment system and make funds available for clients who cannot meet their insurance deductibles and copays.

NewBridge needs your help to avoid a catastrophe. Thank you.

# NewBridge Jobs Plus Graduate Honored by Statewide Organization

A 2016 NewBridge Jobs Plus graduate who turned his life around has been honored by the Garden State Employment and Training Association. Anthony Justo in September received a STAR (Student Training Achievement Recognition) award at GSETA's annual conference in Atlantic City.

Speaking at a luncheon, the 25-year-old described his troubled youth and how he began using drugs and stealing to support his habit. He faced a state prison sentence for a 2012 robbery, but the victim, a chaplain, asked a judge to send Justo to drug court instead. Justo said the program — along with his faith in God — helped save his life.

After seven months at a state treatment facility (he had already served 14 months in jail), Justo went to the Morris/Susses/Warren Workforce Development Board (WDB) and Employment and Training Services (ETS), which connected him with NewBridge Jobs Plus. "Going back to school at age 24 wasn't easy, but everyone at NewBridge Jobs Plus made me feel welcome," he said. "They helped me earn my high school diploma and start a new chapter of my life."

The Parsippany resident is a certified peer recovery specialist helping people who overdose on opioids, and he's pursuing a career in social work. He works full-time at a restaurant and is studying to become a personal trainer. "None of this would have been possible if it wasn't for all of you who showed me love when I couldn't love myself," Justo told the GSETA audience.

The WDB and ETS nominated Justo for the award, which is given to people who overcome barriers and complete their education and gain sustainable employment. "We commend

him for his accomplishments and look forward to hearing about his continued successes," said Donna L. Buchanan, ETS director of program operations.

NewBridge Jobs Plus Grads Ready to Pursue Professions

Meghan Graham had missed too many classes due to sickness to graduate on time from Roxbury High School, so last February she enrolled in NewBridge Jobs Plus and earned her New Jersey High School diploma.

"I feel it's one of the best decisions I've ever made," said Graham, who plans to pursue a career in social work. NewBridge helped her

apply to County College of Morris and to file for financial aid.

Graham was among 35 young adults to don a cap and gown at the NewBridge Jobs Plus commencement on June 23. Parents and friends cheered as graduates took to the podium at the Wyndham Worldwide headquarters in Parsippany and shared tales of overcoming hardships endured in high school before finding their niche at NewBridge Jobs Plus.

"We at NewBridge are so proud of how far these young men and women have come, and are confident their fortitude will propel them to successful, fulfilling lives," NewBridge CEO Robert L. Parker said.

NewBridge Jobs Plus is the longest-running alternative education program in Morris County and has helped well over 1,000 young adults earn their high school diplomas and prepare for college, trade schools and careers since 1983. The program, located at the NewBridge Parsippany Center, is free to young adults living in Morris, Sussex and Warren counties, and transportation is provided to Morris County residents.

Alyce Haygood left Mount Olive High School and found success at NewBridge Jobs Plus.

"I used to feel like I was the only one who struggled in high school, but here I discovered I wasn't alone," she said. As Haygood prepares to study massage therapy at Fortis Institute in Wayne, she has inspired her 21-year-old sister,

Kaylen to attend NewBridge Jobs Plus to pursue her high school degree.
