Strengthening Outpatient Counseling Programs at NewBridge

When New Jersey drastically changed the way it funds community mental health care in 2017, NewBridge was forced to reduce staff and consolidate locations to remain viable.

While fee-for-service funding caused some community mental health agencies to close their doors, NewBridge adapted. The nonprofit

is now pushing ahead to rebuild its outpatient counseling services to meet the great need among children, adults and seniors. (Even with reduced funding from the state, NewBridge succeeded in providing 11 of its 12 valued programs.)

"Ensuring community access to quality services remains our top concern," NewBridge CEO Robert L. Parker said. NewBridge has hired more licensed clinical social workers so it can provide more family therapy sessions. It has also increased the number of psychopharmacology sessions for people who require medication as part of their treatments, he said.



The nonprofit is also adding group therapy sessions dealing with anxiety and depression, and medication education, and plans to offer more group sessions in the near future, Parker said.

NewBridge's psychiatrists, addiction specialists, counselors, and social workers:

- Treat children, adults and seniors with mental illnesses or addiction (or both)
- Counsel children, adults and families, teaching them skills to cope with stress, grief and challenging relationships
- Conduct psychiatric evaluations and medical monitoring
- Provide **psychological first aid** during crises

NewBridge Trains in MHFA to Combat Suicide

With suicide rates on the rise, NewBridge is teaching people how to respond effectively to mental health crises through Mental Health First Aid (MHFA) training.

"The goal is to arm as many adults as possible with skills to recognize when a person is in crisis and effectively intervene," NewBridge Director of Community Response and Education Mary Vineis said. NewBridge began teaching MHFA for adults in 2013, and has added specialized trainings for helping children and adolescents, and college students.

The suicide rate in the U.S. climbed nearly 30 percent between 1999 and 2016, according to a Centers for Disease Control and Prevention report released in June. In New Jersey, the suicide rate is up 19.2 percent.

"MHFA training has been shown to diffuse crises and stop people from ending their lives," Vineis said. Suicide is the 10th leading cause of death in the U.S. The eight-hour, evidence-based training helps people identify, understand, and respond to signs of mental illness.

September was National Suicide Prevention Awareness Month. Visit newbridge.org/education/suicide-prevention-awareness for information and tips on how you can help a person in crisis.

So far in 2018, NewBridge has trained 126 adults in Youth Mental Health First Aid (YMHFA). About 170 people over the past five years have been trained in adult MHFA, including a version geared for public safety professionals, Vineis said.

NewBridge has been counseling children, adolescents, and adults struggling with depression and suicidal thoughts for decades. In the schools, Vineis teaches suicide prevention programs for pre-teens and teenagers and offers workshops for parents and educators. NewBridge also responds when a crisis strikes in a community. Vineis plans to conduct another YMHFA training for the public in November or December, funded by a Morris County grant. Donning caps and gowns, members of NewBridge Jobs Plus Class of 2018 walked across a stage at Wyndham Worldwide headquarters in Parsippany on June 14, as more than 200 supporters cheered.

"We are so proud of our graduates for not giving up on themselves when traditional high schools failed them," NewBridge Chief Operating Office L. Michelle Borden said. "They persevered and overcame challenges to get themselves on track for a better future."

The NewBridge Jobs Plus Class of 2018 was made up of 44 young adults who left traditional high schools. With support from NewBridge's alternative education and jobs program, they earned New Jersey high school diplomas and prepared for careers.

Started in 1983, NewBridge Jobs Plus is the longest-running alternative education program in Morris County. The program, located at the NewBridge Parsippany Center, is free to young adults living in Morris, Sussex and Warren counties, and transportation is provided to Morris County residents.
